LAWNS AND OTHER ORNAMENTAL AND
RECREATIONAL TURF GRASS AREAS

FIRE ANT CONTROL - Apply as a drench to ant mounds diluting spray at the rate of 5-1/3 oz. in 4 gallons water. Gently sprinkle a total of 1 gallon of the diluted solution over the surface of each mound using a sprinkler can. Thoroughly wet mound and surrounding area to a 4 ft. diameter (12 sq. ft.). For best results apply in cool weather, 65° - 80°F, or in early morning or late evening hours. Treat new mounds as they appear. Pressurized sprays may disturb ants and cause migration, reducing product effectiveness.

PROTECTIVE BAND & FOUNDATION SPRAY

BAND SPRAY TREATMENT - To help prevent infestations of buildings by Ants, Crickets, Earwigs, Millipedes and Sowbugs (Pillbugs), treat a band of soil 6 to 10 feet wide around and adjacent to buildings also the building's foundation to a height of 2 to 3 feet where pests are active and may find entrance. Use 4-1/4 ounces in 10 gallons of water to treat 1,000 sq. ft. (10 ft. band x 100 feet long).

ATTENTION (Turf and Ornamental Plant Pests). Keep children and pets off treated areas until spray has dried. Keep out of lawn & garden fishpools and other bodies of water. Do not allow livestock to graze in treated area. Do not feed treated grass cuttings or seed screenings to livestock nor use hay for livestock bedding.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not re-use empty container. Wrap container and put in trash collection.

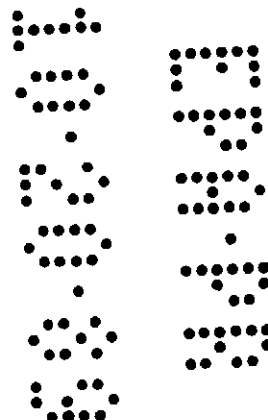
