TIME TO APPLY: Apply any time broadleaf weeds are present, except to avoid treating St. Augustine Grass in summer months (June thru September) when it is growing rapidly, because temporary foliage discoloration may occur. Best results are obtained when weeds are young and growing vigorously. If weeds are growing slowly, control will be slow and more than one application may be needed. Moisture from dew or watering on weak foliage at time of application aids control. Do not water for 24 to 48 hours AFTER application. Do NOT use on Dichondra or Lippia ground cover or similar covers. Do NOT apply in areas underlaid by roots of desirable trees and shrubs. Do NOT use on newly seeded lawns.

HOW MUCH TO APPLY: Use 20 lbs. on 5,000 sq. ft. for Bahia, Bermuda, Centipede, Fescue and St. Augustine Grasses. Over-application may cause temporary discoloration.

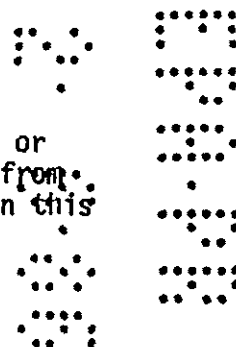
