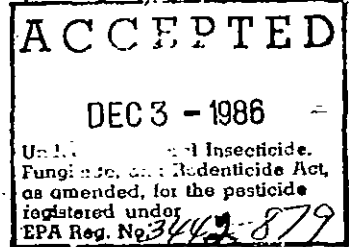

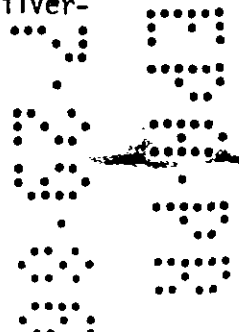

Vertagreen with TEAM is a selective preemergence herbicide and fertilizer combination for the control of crabgrass and most other annual weed grasses on lawns in established: Bluegrass, (perennial), Ryegrass (perennial), Fescue, Bahiagrass, Bermudagrass, Centipedegrass, St. Augustinegrass, Zoysiagrass.

Vertagreen with TEAM, when applied as directed, controls the following: Annual Bluegrass (Poa annua), Smooth Crabgrass, Hairy Crabgrass, Goosegrass (Silvergrass), Barnyardgrass (Watergrass), Green Foxtail, Yellow Foxtail.

Crabgrass, Foxtails and Barnyardgrass - Apply the contents of this bag over 5,100 square feet in the spring, one to two weeks prior to crabgrass germination.

Goosegrass - Normally germinates 4-6 weeks after crabgrass. Apply the contents of this bag on 5,100 square feet in late spring or early summer, with a second application 45 days later.

Poa Annua - Apply contents of this bag in 5,100 square feet in late summer or early fall and again in late winter or early spring. A second application may be needed 45 days after the initial treatment. In areas of heavy infestation of annual bluegrass, its elimination will temporarily result in thin turf grass areas. Proper fertilization, irrigation and re-seeding will encourage existing turfgrass to fill in areas previously filled by annual bluegrass.

RESEEDING - Reseeding should be delayed at least 6 weeks after treating with Vertagreen Lawn Food with Team Crabgrass Control.

PRECAUTIONS - Apply Vertagreen Lawn Food with Crabgrass Control to lawns prior to the germination of annual weed grasses, since Team will not control established weeds. This product may thin established annual bluegrass (Poa annua) turfs and fine-leaved fescues. Do not apply in the spring to lawns planted the previous fall. In Bermudagrass lawns that have been overseeded with winter grasses, a spring application of this product may thin over-seeded grasses. Do not use on Dichondra. Do not use on newly sprigged areas of Bermudagrass, St. Augustinegrass, or Centipede grass until these turfs are well established.

Avoid getting on concrete walks, stucco or asbestos siding, as the composition of certain fertilizer elements can cause permanent stain.

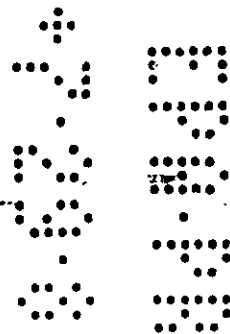
