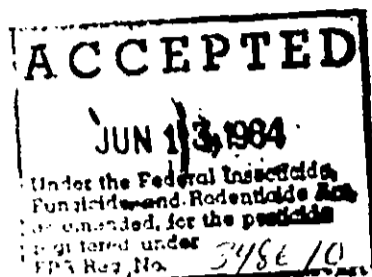

Statement of Practical Treatment

For Eyes: In case of contact with eyes, flush with plenty of water for at least 15 minutes. Call a physician.

DANGER

(18 pt)

Corrosive: Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Wear goggles or face shield when handling. Harmful or fatal if swallowed. Avoid contamination of food or feed.

Environmental Hazards

This product is toxic to fish and wildlife. Do not apply directly to water or wetlands. Do not contaminate water by cleaning of equipment or disposal of wastes.

Contains petroleum distillate. Do not use, pour, spill or store near heat or open flame.

Instructions for Application

ATCO #1410 Penta Ten-To-One Concentrate is a clean, clear and low odor dilutable pentachlorophenol liquid treatment for use on all exterior wood exposed to moisture or soil. It saturates deep into wood to combat dry rot, mildew, mold, fungus, termites, ants and wood beetles. It can be painted over (except with water base stains) and protects the paint against peeling and blistering. Penta Ten-To-One Concentrate is insoluble in water. It may be used on wood shake and wood shingle roofs and on brickwork to resist moss growth.

Dilute Penta Ten-To-One Concentrate with 10 parts of fuel oil, diesel oil, paint thinner or kerosene. Dilute only with paint thinner if it is to be painted over. Wood to be treated should be dry, seasoned and free of bark and foreign matter for best results. Whenever practical, wood should be dipped into diluted product. Lumber should be immersed for at least 3 minutes. Dip fence posts for 24-48 hours. Use about 1/2 gallon of treating solution for each cubic foot of wood. If a brush-on method is used, get as much penta solution on the wood as possible without excessive run-off. Let dry and apply another heavy coat. One gallon of solution will treat 150-250 square feet.
