
### **DIRECTIONS FOR USE**

Pour specified amount of this material into nearly filled spray tank. Add balance of water to fill tank, Keep agitator running during filling and spraying operations. If mixture does not mix readily, but tends to separate as an oily layer, do not use as injury to plants may result. Do not combine with wettable powders unless previous use of the mixture has proven physically compatible and safe to plants. Always thoroughly emulsify this product with at least half of total water before adding wettable powder.

## RECOMMENDATIONS

APPLES: Aphids - Use 1 qt in 100 gals. Apply before 60 days of harvest or not after fruit starts to form.
