Apply dust when insects first appear and repeat at 7 to 10 day intervals as required to maintain control. Apply thoroughly to upper and lower leaf surfaces. Sevin*-Sulfur with Zinc Carrier may be applied up to the day of harvest. **POTATOES:** Colorado Potato Beetle, Flea Beetle, Leafhopper, Fall Armyworms, Stink Bugs, Tarnished Plant Bugs - Use 20 to 40 lbs. per acre.
