

HAZARDS TO HUMANS AND DOMESTIC ANIMALS"

7. Add the following to the "HAZARDS TO HUMANS..." section:

"Wash thoroughly after handling and before eating or smoking."

- 8. You should delete the duplicative information $r_{\sim i}$ -laced by the STATEMENT OF PRACTICAL TREATMENT.
- 9. Replace "OR NURSING PUPPIES" to "PUPPIES UNDER 3 MONTHS OF AGE OR NURSING BITCHES."
- 10. Immediately preceding "This product is toxic to fish..." insert the following heading:

"ENVIRONMENTAL HAZARDS

11. Revise the first sentence of your "ENVIRONMENTAL HAZARDS" section to read as follows:

"This product is toxic to fish, birds and other wildlife.

12. Add a third sentence in this section to read:

"Do not contaminate water by cleaning of equipment or disposal of wastes."
