MICE: Apply 1/4-1/2 oz. (1-2 tablespoons) of bait at 8 to 12 foot intervals. Larger placements (up to 2 oz.) may be needed at points of extremely high mouse activity. Space placements at intervals of 8-12 feet. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Collect and properly dispose of all dead animals and leftover bait. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment.
