Storage: Do not contaminate water, food, or feed by storage or disposal.

Store in a cool dry place. Do not store where children or animals may gain access.

Pesticide Disposal: Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

b. The Storage and Disposal Statement for Homeowner Use must read as follows:

Storage: Store in a cool dry place. Do not store where children or animals may gain access.

Disposal: Securely wrap original container in several layers of newspaper and discard in trash.
