DIRECTIONS

SAFE-WAY BRAND FLY BAIT is a ready-to-use, highly effective insecticide. No mixing, preparation, or application equipment is required. By means of the handy, shaker-top canister, sprinkle the bait lightly on the floor of barn, window sills, stanchion area and stalls, out of reach of animals. This material should be applied mainly in areas where flies are likely to congregate on the floor, particularly sunny areas; therefore, only a small portion of the total area of the barn floor needs to be treated.

APPLICATION RATES: Use SAFE-WAY BRAND FLY BAIT on floors of dairy barns, livestock loafing sheds, calf barns, hog barns, poultry houses, and areas outside the home. Apply at the minimum rate of 1/4 pound per 1,000 square feet of actual treatment area, depending on the intensity of fly population. Apply daily until fly population has been reduced; thereafter, apply as needed, especially in favorite congregating areas on the floor. The contents of this can should treat an average barn 3 to 4 times.

NOTE: Treatment of posts, beams, wires, pipes, and other favored fly resting places above floor level with MALATHION E-5 plus the sprinkling of SAFE-WAY BRAND FLY BAIT as directed is a very effective control combination.
