
## DIRECTIONS

FLIES, MOSQUITOES, WASPS, GNATS, FLYING MOTHS and other small flying insects may be controlled by spraying upwards toward the center of the room from each corner. A total of 10-15 sec. spraying time should be allowed for each 1,000 cu, ft. of room, Windows and doors should remain closed for about 15 min. after treatment.

ROACHES, ANTS, TICKS, SILVERFISH, SPIDERS, CENTIPEDES, AND MILLIPEDES may be controlled by spraying cracks of woodworks, around doors, window frames, baseboards, under sinks, in cupboards, closets, and under shelving where insects walk, hide, or nest. The undersides of furniture and in drawers or other dark places should be treated.

FOR FLEAS AND TICKS IN ANIMAL QUARTERS remove animal and spray all corners and cracks of quarters. Bedding etc. should also be sprayed thoroughly.

FOR BEDBUGS, take bed apart and spray all surfaces and cracks of bedstead. Mattresses and springs should be thoroughly sprayed giving special attention to seams, beading, and buttons. Air mattress for at least four hours before reuse. Be sure mattress is dry.
