
BEEF CATTLE: Horn Flies, Lice, Ticks-Mix | gal. SAFE-WAY BRAND TOX O' MAL #45 with 100 gal. water and apply to animals as a strong spray to penetrate hair to the skin. Make thorough application and repeat as needed. When tail lice are present spray with a mixture of  $\frac{1}{2}$  gal. of TOX O' MAL to 100 gal. of water. A second application should be made in 2 weeks. If ticks are numerous and active it is well to repeat treatment in 2 weeks. For spinose ear tick, apply spray as a low pressure mist into the ears and to head and neck.

HORSES: Ticks—I gal. per 100 gal. water. Apply as directed under Cattle. If spraying is objectionable horses may be thoroughly sponged with the spray mixture. Colts under 3 months of age should not be treated.

SHEEP AND GOATS: Ticks-mix I gal. in 100 gal. water and apply as a spray thoroughly wetting skin. Repeat as necessary. Lice. Sheep Ticks (Keds)—mix at the rate of 12 oz. to 100 gal, water and make a thorough application. Fleece Worms-apply a spray prepared by mixing I gal. SAFE-WAY BRAND TOX O' MAL #45 in 150 gal. water and repeat as necessary. Do not apply to goats producing milk for human consumption.
