

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ONE OUNCE WILL PROVIDE APPROXIMATELY 0.25 ppm OF AVAILABLE CHLORINE IN 10,000 GALLONS OF WATER.

### START UP:

1. Adjust pH of pool water to 7.2 to 7.6 range with Utikem pH control chemicals.

2. To a clean pool which is free of visible algae, add approximately 5 oz. for every 10,000 gallons of water.

3. Test water for chlorine residual using a Utikem Test Kit.

- 4. If chlorine residual is below 1.0-1.5 ppm, repeat treatment until proper level is reached.
- 5. If your pool has not been stabilized previously, add Utikem Chlorine Stabilizer & Water Conditioner (Cyanuric Acid) according to label directions.

### REGULAR CARE:

- 1. After start up, add approximately 5 oz. of Utikem Chlorinating Powder Concentrate for every 10,000 gallons of water every other day or as needed to maintain a chlorine residual of 1.0-1.5 ppm as determined by your test kit.
- 2. Check pool water daily with your Utikem Test Kit and maintain a chlorine residual of 1.0-1.5 ppm and a pH of 7.2-7.6. Adjust pH if necessary using Utikem pH control chemicals.
- 3. During extremely hot weather and/or heavy bathing loads, additional treatment may be required.
