UTIKEM SUPER-SHOCK TREATMENT provides an easy instant method for super chlorination. High chlorine residuals can be obtained with the addition of UTIKEM SUPER-SHOCK TREATMENT granules to your pool. This calcium-free product gives fast chlorination without cloudiness. Specially recommended for use in starting up pools at the beginning of the season when super chlorination is required.

DIRECTIONS

For 24 ft. diameter (24' diam. x 48" high) pools of approximately 13,500 gallon capacity, add entire contents of this container. For other pools add 2 oz. by weight for each 1,000 gallons of pool water.

Allow several hours for SUPER-SHOCK TREATMENT to destroy the algae, preferably overnight. Vacuum or brush the dead algae from the pool bottom, if possible.

Before using the pool again check the chlorine residual. If chlorine residual is above 2.0 ppm the pool should remain un-used until the chlorine residual drops to below 2.0 ppm as determined by a suitable chlorine test kit.

DANGER: Keep Out of Reach of Children. Corrosive strong oxidizing material. Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Protect eyes when handling product. Avoid breathing dust. Harmful or fatal if swallowed.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
