

**DIRECTIONS FOR USE
GENERAL CLASSIFICATION:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

UTIKEM BLACK ALGAE KILLER is used to control the growth of algae in exterior spas, whirlpools, and hot tubs. For maximum effectiveness, spas, whirlpools, or hot tubs containing heavy growth of algae should be cleaned prior to using UTIKEM BLACK ALGAE KILLER. For spas, whirlpools, or hot tubs having just visible algae growth add an initial dose of 1 to 2 fluid ounces of UTIKEM BLACK ALGAE KILLER per 1,000 gallons of water. For treatment of freshly cleaned and filled spa, whirlpool, or hot tub, add initially 0.6 to 1.1 fluid ounces of UTIKEM BLACK ALGAE KILLER per 1,000 gallons of water. To maintain spas, whirlpools, or hot tubs free of visible algae growth, subsequent additions of 0.2 to 0.4 fluid ounces of UTIKEM BLACK ALGAE KILLER per 1,000 gallons of water should be made every 5 to 7 days after the initial treatment. UTIKEM BLACK ALGAE KILLER is compatible with those chemicals normally used to treat spas, whirlpools, and hot tubs and is effective at both acid and alkaline pH. UTIKEM BLACK ALGAE KILLER can be used in spas, whirlpools, and hot tubs treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix UTIKEM BLACK ALGAE KILLER with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL:

Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal, or cleaning of equipment. Do not reuse empty container. Triple rinse (or equivalent) and dispose of container in an incinerator or in an approved landfill, or bury in a safe place. Rinse that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.
