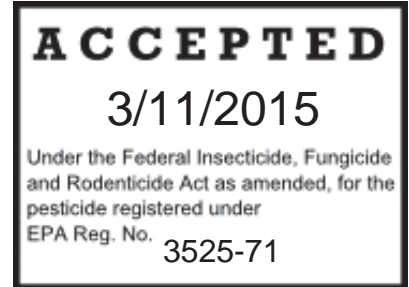

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Utikem Black Algae Killer controls the growth of microscopic plants called algae, which thrive in warm, sunlit pools. It is algae that turns the water green and produces odors that make swimming unpleasant. This condition is controlled by the addition of Utikem Black Algae Killer at periodic intervals throughout the swimming season to prevent algae from growing. It is important to note that small amounts of Utikem Black Algae Killer added at regular intervals will do a better job at algae prevention control than large amounts added only where algae has become a nuisance.

REGULAR CARE:

For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using Utikem Black Algae Killer. For pools having just visible algae growth, add an initial dose of 11 to 17 fluid ounces of Utikem Black Algae Killer per 10,000 gallons of water and remove settled algae debris, by cleaning. For treatment of a freshly cleaned and filled pool, add initially 6 to 11 fluid ounces of Utikem Black Algae Killer per 10,000 gallons of water.

To maintain pools free of visible algae growth, subsequent additions of 2 to 4 fluid ounces of Utikem Black Algae Killer per 10,000 gallons of water should be made every 5 to 7 days after the initial treatment.

Utikem Black Algae Killer is compatible with those chemicals normally used to free pools and is effective at both acid and alkaline pH. Utikem Black Algae Killer can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix Utikem Black Algae Killer with concentrated dry or liquid chlorine products..

Add Utikem Black Algae Killer directly to pool water.

Never mix pool chemicals together. Always add them separately.

{USEFUL POOL FACTS – ESTIMATING POOL CAPACITY}

Rectangular & Square Pools: Multiply length in feet x width in feet x average depth in feet x 7.5 = Pool capacity in gallons

Round Pools: Multiply diameter in feet x diameter in feet x average depth in feet x 5.9 = Pool capacity in gallons.

Oval Pools: Multiply longest diameter in feet x shortest diameter in feet x average depth in feet x 6.7 = Pool capacity in gallons. }
