

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INITIAL TREATMENT: Permacide Liquid Permanent Algaecide* must be added to pool water free of visible algae. To insure this condition, superchlorinate pool water. Then add Permacide Liquid Permanent Algaecide to pool water as indicated in the dosage table below after allowing the chlorine residual to fall to 2.0 ppm. Do not enter the pool until the chlorine residual falls to 2.0 ppm.

PERMACIDE PERMANENT ALGAECIDE DOSAGE CHART (For Initial Treatment Upon Filling Pool)

POOL GALLONAGE	INITIAL AMOUNT
675 gallons	1 cupful
2,700 gallons	1 quart
5,400 gallons	1/2 gallon
10,800 gallons	1 gallon

Using the dosage recommended above, apply the proper amount by directly adding to the pool as you walk around the outside edge.

*Permanency is approximately 1 month depending on weather conditions and bather load.
