Tarry Chlorinating 1 oz. Tablets are to be used as a disinfectant and algae control in pool water. They are long-lasting and are intended to slowly meter chlorine into pool water. In order to obtain its maximum effect, use as follows:

- 1. Superchlorinate the pool water with one of Coastal's fast-acting stabilized chlorines, following directions on the label for that product. Do not use the pool until the chlorine residual drops to 2.0 ppm (parts per million).
- 2. Adjust the cyanuric acid level in pool water to 30 ppm (parts per million) with Coastal's Chlorine Stabilizer, following directions on the label for that product.
- 3. Suggested daily dosage is one Tarry Chlorinating 1 oz. Tablet per 3,600 gallons of pool water into floating dispenser or top water skimmer. This dosage may vary in accordance with temperature, bather load and amount of water flow. Using a PoolChem test kit as a guide, maintain a 1.0 to 2.0 ppm free chlorine residual.
