

General Comments:

1. Remove the "Keep Out Of Reach of Children" statement from the precautionary statement. The statement is only required on the front panel, immediately below the ingredient statement.

2. The precautionary statement must be revised to read as follow:

Harmful if Swallowed. Avoid breathing vapors. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after handling.

Algon 60 Algaecide is compatible with chlorinating products and other chemicals used to treat swimming pools and may reduce the amount of those chemicals normally required. However, DO NOT mix this product with concentrated dry or liquid chlorinating products.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Algon 60 Algaecide is used to control the growth of many algae types, including green, black and mustard algae. For treatment of a freshly cleaned and filled pool, add an initial dose of 6 to 12 fl. oz. Algon 60 Algaecide per 10,000 gallons of water. For maximum effectiveness, heavy growth of algae should be cleaned prior to use of Algon 60 Algaecide. prowin or aigae should be cleaned prior to use of Algori 60 Algaecide. Pools containing just visible algae growth should receive an initial dose of 12 to 18 fl. oz. of Algon 60 Algaecide per 10,000 gallons of water. After 24 hours, vacuum pool to remove algae debris. On a regular basis, (every 5 to 7 days), use a maintenance dose of 2 to 4 fl. oz. of Algon 60 Algaecide. per 10,000 gallons of water.
