STATEMENT OF PRACTICAL TREATMENT

FIRST AID: IF ON SKIN, brush off excess chemicals and flush skin with cold water for at least 15 minutes. If irritation persists, get medical attention. IF INHALED, remove person to fresh air. Get immediate medical attention. IF IN EYES, flush with cold water for at least 15 minutes. Get immediate medical attention. IF SWALLOWED, promptly drink large quantities of water. DO NOT induce vomiting. Call a physician immediately. See back panel for additional precautions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Reentry into treated swimming pools/spas is prohibited above levels of 3.0 ppm.

Coastal Winter-Chlor Long-Lasting Chlorinating Tablets are to be used to help control, by disinfectant and algaestatic action, swim pool odors and algae during winter months. Each tablet weighs 5-1/3 oz., and each 3-tab basket of Winter Chlor Long-Lasting Chlorinating Tablets treat up to 22,000 gallons of water. They are intended to slowly meter chlorine into pool water. In order to obtain its maximum effect, use as follows:

1. Remove all debris from pool by skimming surface, running filter and vacuuming foreign particles from bottom of pool.
2. Superchlorinate with Coastal One Shot Shock or Iso Clor. Continue running filter pump. When the free chlorine residual reduces to 1 to 3 ppm (parts per million), add Coastal Winterizer while walking around the edge of the pool. Then remove the 3-tab basket(s) of Winter-Chlor Long-Lasting Chlorinating Tablets from plastic bags, and drop basket(s) into water toward center of the pool.
3. Drain any water from filter and pool piping to prevent freezing. Disconnect filters, pipes, chlorinators, lights, etc.
4. Cover the pool with a winter pool cover.

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STORAGE AND DISPOSAL

Keep this product dry in tightly closed container when not in use. Store in cool, dry, well ventilated area away from heat and open flame. In case of decomposition, do not reseal container. Isolate container, if possible, in open air or well ventilated area. Flood with large volumes of water to dissolve all material before discarding container. Do not reuse empty container, but place in trash collection. Do not contaminate food or feed by storage, disposal or cleaning of equipment. Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. ISOCYANURATE RED ATTACHMENT A

LABELING: (Statements are based on review of referenced acute toxicity data)

1. The signal word is "DANGER"
2. Revise the Precautionary Statements to read:

CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through skin. May be fatal if inhaled. Do not breathe dust or spray mists. Irritating to nose and throat. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

3. Revise the Statement of Practical Treatment to read:

STATEMENT OF PRACTICAL TREATMENT.

IF SWALLOWED: Drink promptly large quantities of water. Do not induce vomiting. Avoid alcohol. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably, mouth-to-mouth. Get medical attention.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.
