The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Poly(oxyethylene [dimethyliminio] ethylene [dimethyliminio] ethylene dichloride RED, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

NOTE: This product is not yet being reregistered under section 4(g) of FIFRA.

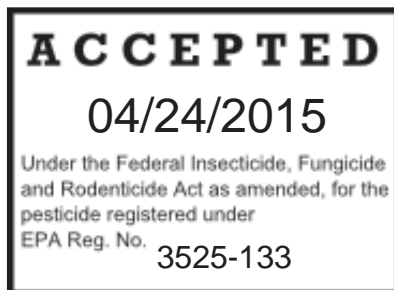

This product controls algae growth in swimming pool water without causing foaming. This product is effective at both high and low pH levels. This product is compatible with chlorinating products and other chemicals used to treat swimming pools and may reduce the amount of those chemicals normally required. However, DO NOT mix this product with concentrated dry or liquid chlorinating products.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This product is used to control the growth of many algae types, including green, black and mustard algae. For treatment of a freshly cleaned and filled pool, add an initial dose of 12 to 24 fl. oz. this product per 10,000 gallons of water. For maximum effectiveness, heavy growth of algae must be cleaned prior to use of this product. Pools containing just visible algae growth must receive an initial dose of 24 to 36 fl. oz. of this product per 10,000 gallons of water. After 24 hours, vacuum pool to remove algae debris. On a regular basis, (every 5 to 7 days), use a maintenance dose of 4 to 9 fl. oz. of this product per 10,000 gallons of water. During, hot sunny weather, more frequent additions may be necessary. This product will prevent the growth of most algae during the off season, when the pool is not in use. For pools which have been properly treated during the swimming season, and are free of visible algae, add 13 to 21 fl. oz. of this product per 10,000 gallons of water. If at the end of the season, the pool has some visible algae growth, add 25 to 27 fl. oz. of this product per 10,000 gallons of water. For best results, circulate the pool water, prior to covering the pool for the winter.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing.
