

Then superchlorinate with Blast One Shot Shock Treatment or Iso Clor Super Stabilized Chlorinating Powder to establish a free chlorine residual of 1.0 to 1.5 ppm (parts per inillion). If your pool has not been stabilized previously, add Coastal Chlorine Stabilizer (cyanuric acid) until 30 ppm is obtained following latel directions.

DAILY: Add Tab-A-Day Daily Chlorinating Tablets to the pool skimmer or floating dispenser as necessary to maintain a 1.0 to 1.5 ppm chlorine residual.
