Tab-A-Day Daily Chlorinating Tablets provide effective control of bacteria and algae growth in pool water. DO NOT add this product directly to pool water or to continuous tablet chlorinating devices. Tab-A-Day Daily Chlorinating Tablets are interded for addition to the pool skimmer or Into a floating dispenser. Do not mix this product with any other chemical.

DIRECTIONS FOR USE It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Reantry into treated swimming pools/spas is prohibited above levels of 3.0 ppm. START-UP: When starting up a reopened or freshly filled swimming pool, make sure that the filtation system is clean and operating properly. Then adjust and maintain the pH in the range of 7.2 to 7.8. Use Coastal pH Plus or pH Minus as indicated by a PoolChem Test KII. Then superchiofinate with Blast One Shot Shock Treatment or Shock X+ra to establish a free chlorine residual of 1.0 to 1.5 pm (parts per million). If your pool has not been stabilized previously, add Coastal Chlorine Stabilizer (cyanuric acid) unit 30 pm is obtained following their directions:

acid unt 30 opm is obtained following label directions.
