The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

- 1. The Agency's records have been changed to reflect the change in the primary brand name to "Lynwood Multi-Purpose Insect Killer."
- 2. You must revise the Statement of Practical Treatment to read as follows:

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouthto-mouth. Get medical attention.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

3. You must revise the heading "ENVIRONMENTAL HAZARD" to read "ENVIRONMENTAL HAZARDS".

A stamped copy of the label is enclosed for your records. Submit three copies of revised final printed labeling prior to releasing product for shipment.

The confidential statement of formula referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below:

- 1. You must revise the lower certified limits for each component in the formulation to reflect standard certified limits, as specified at 40 CFR 158.175. As currently listed on the confidential statement of formula (dated May 30, 1996), the proposed lower certified limits are equal to the nominal concentration.
- 2. You must provide the correct Chemical Abstracts Service (CAS) Number for the propellant.

Submit the revised confidential statement of formula for the record.

For best fog shake between sprays. Point valve away from face and press button. Direct spray to control pests when possible. Hold can at least 3 feet from surfaces which may stain. The waterbased spray will not stain when used as directed.

#### STORAGE AND DISPOSAL

Wrap container and dispose of in trash. Do not incinerate or puncture can.

# FOR CONTROL OF PESTS ON ORNAMENTAL PLANTS

Spray plants with a slow sweeping motion so that mist drifts into plants. Spray will go up to 6 feet. Use care on new growth and tender foliage. Repeat as necessary. When using outdoors, spray when air is still.

For control of Japanese beetles, aphids, two-spotted spider mites, beetles and adult white flies on outdoor plants (Roses, Rose Sharon, Azalea, Chrysanthemum, Euonymus, Ivy, Marigold, Petunia, Zinnia) Snapdragon and and ornamental house and greenhouse plants(African Violets, Aralia, Christmas Cherry, Chrysanthemum, Cineraria, Diffenbachia, Fuschia, Gloxinia, Euonymus, Ivy, Lantana, Bella Palm, Marigold, Neanthe ' Petunia, Rose, Snap Dragon.

#### TREES AND SHRUBS

GYPSY MOTHS, TENT CATERPILLARS also Canker Worms, Garden Webworm, Aphids, Spider Mites and Adult White Flies on ornamental crabapples, cherries and plum trees, spray as above. Do not spray fruit bearing trees.

### HORNETS-WASPS-YELLOW JACKETS

Kills Hornets, Wasps and Yellow Jackets nesting in ornamentals and trees and Shrubs, Rhododendrons, Yews, Laurels, etc. Fog preferably in the evening when air is still or direct spray at these insects using short bursts. Spray thoroughly into nests, hiding and breeding places when insects have settled at night.

## FOR CONTROL OF PESTS AROUND THE HOME

FLYING INSECTS(Flies, Mosquitoes, Gnats and Moths) -Direct Spray at insects using short bursts (1 or 2 seconds) or treat unoccupied areas as follows: Close doors and windows. With a sweeping motion direct spray upward to all parts of the room (8 to 10 seconds per 1000 cubic feet). Keep room closed for 15 minutes and ventilate before reoccupying. Sweep up and destroy fallen insects.

CRAWLING PESTS(Ants, Boxelder Bugs, Crickets, Earwigs and Sowbugs)-Spray into cracks or woodwork, walls, floors and other hiding and breeding places. Direct spray to contact pests when possible. Spray ant trails and areas around door sills and window frames,
