INSTRUCTIONS: 1. Shake before use. 2. Squeeze only to dispense. 3. Close cap after use.

1. TO CLEAN SHOWERS, TUBS, TILE SINKS, CHROME

Apply directly to surface or damp sponge, rub and rinse. For tough jobs, let soak. Use a brush on grout.

AVOID SOAKING ON PORCELAIN SINKS AND TUBS [or] SURFACES FOR MORE THAN 30 MINUTES

2. TO CLEAN FIBERGLASS AND MODERN SURFACES

Take special care with these surfaces. Apply using a damp sponge and let soak a while. [or] Let soak. Rub gently, if needed and rinse.

3. TO CLEAN STOVETOPS, RANGES, POTS & PANS

Apply directly to greasy soils, scour and rinse. Repeat if needed. DO NOT USE ON SILVER, ALUMINUM OR RUBBER ITEMS.

4. TO DISINFECT TOILET BOWLS

Flush toilet [or] first. Apply above waterline and under and around rim of bowl (4 oz). Let soak minutes, swab [or] brush all surfaces thoroughly and flush.
