It has come to our attention that on page 7 of the January 31, 2013 stamped accepted label there are two occasions where the wording "safely cleans…" is used in the 'Cleaning and Deodorizing Claims" table of the label. Since we were recently informed by the Agency of the need to remove a similar claim from another registered product master label, we are taking this opportunity to inform the Agency that we are also removing this claim from the Comet Disinfecting Bathroom Cleaner label.

Thus, PR Notice 98-10, The Procter & Gamble Company is submitting the following notification for the deletion/ removal/replacement of the claim "Safely" in the two locations on page 7 of the subject Master Label.
