

CELERY: For control of Early Blight (Cercospora) and Late Blight (Septoria) and Aphids. Apply when plants are established in the field and repeat at 7 to 10 day intervals as long as blight threatens or insects are noted. Apply 20 to 25 lbs. per acre. Do not apply within 7 days of harvest. Remove excess residue by stripping, trimming and washing.

POTATOES: For control of Early and Late Blight, False Chinch Bug, Aphids and Leafhoppers. Start applications as soon as the plants are 2 to 6 inches high and repeat at 7 to 10 day intervals as long as blights threaten or insects are noted. Apply 20 to 40 lbs. per acre.

TOMATOES: For control of Early and Late Blight, Septoria Leaf Spot, Grey Leaf Spot (Stemphylium), Anthracnose, Aphids, Russet Mites, Flea Beetle and Leafhoppers. Apply soon after plants have been set to the field. Repeat applications at 7 to 10 day intervals as needed. Apply 20 to 35 lbs. per acre. Do not apply within 1 day of harvest.
