

#### DIRECTIONS FOR USE

**HOUSEHOLD INSECTS:** Use 3 tablespoons of this product in 1 qt. of water, and apply as a coarse spray or brush around window frames, baseboards, drain boards, under sink, and stoves, cracks, and crevices to control ants, spiders, silverfish, crickets, clover mites, and earwigs. Be careful not to contaminate food or utensils. Water base sprays may stain finished surfaces. Repeat application as necessary.

**FLY CONTROL:** Spray all surfaces where flies water.
