

Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 0.3 ounces of undiluted concentrate per 1000 cubic feet of space. Direct output from aerosol generator upward toward upper corners of room and ceiling. Leave room closed for one hour. Ventilate room thoroughly before reentering. Repeat as necessary.
