**DIRECTIONS FOR USE**

**ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS:** Spray heavily in all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, etc. Use on other localized areas infested with these pests. Repeat treatment as required.

**FLIES, MOSQUITOES, WASPS AND FLYING MOTHS (Outdoors):** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Repeat treatment as required.

**FLEAS, CHIGGERS, ANTS AND BROWN DOG TICKS (Outdoors):** For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place.
