STORAGE AND DISPOSAL

Store in a cool area away from heat or open flame.
Disposal: Do not reuse empty container. Wrap container and put in trash collection.

TO KILL WASPS AND HORNETS: Stand a safe distance (8-12 ft.) from the nest and not directly underneath. Aim valve toward nest with wind at your back. Spray until nest is thoroughly wet. Hit wasps or hornets at rest, do not try to spray insects in flight. The best time to spray is early in the morning or at dusk when wasps and hornets congregate in their nests. After at least 24 hours, remove the nest and destroy.

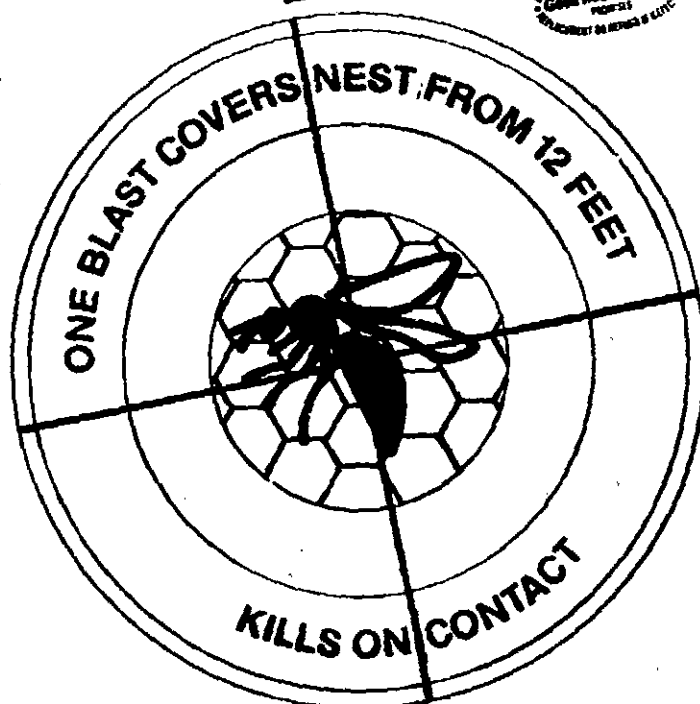
