Amendment Dated October 12, 1995

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling.

a. On the back panel of your label, include the heading "STORAGE AND DISPOSAL" to fall directly above the disposal instructions

b. On the back panel, specify the full name of the microorganisms for which efficacy data has been developed. Change "...Salmonella and Staphylococcus..." to Salmonella cholerasuis and Staphylococcus aureus".

c. "Healthy" and "you breathe easy" are health related claims. Implied or stated health and/or safety claims are not acceptable on pesticide labeling. Therefore, on the back panel, remove the statement "Be confident that your family's home is clean and healthy", and "An outstanding clean that lets you breathe easy".

Example of acceptable statements are:

"Be confident that your family's home is clean and sanitary" and "An outstanding clean without irritating fumes or odors".

d. On the front panel, place the signal word "Caution" and the child hazard warning statement to fall directly below the ingredient section.

2. The proposed alternate Confidential Statement of Formula (CSF) dated October 10, 1995 is in compliance with PR Notice 91-2, it agrees with the label and is acceptable. This alternate CSF supersedes the alternate CSF dated September 25, 1989.

3. The submitted confirmatory efficacy data is acceptable to support the formulation change.

A stamped copy of the labeling is enclosed for your records. Submit one (1) copy of the final printed label prior to release of the product for shipment.
