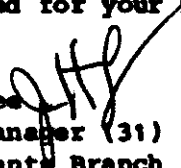

Directions for Use
GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Septo is a proven "one-step" disinfectant - cleaner - sanitizer - fungicide - mildewstat - virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination

Apply Septo to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, procelain and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection - to disinfect hard, non-porous surfaces, add 1 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. Fungicidal Control

Septo is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc. at 1 oz/gallon.

Mold and Mildew Control

At 1 oz/gallon, Septo will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.
