The amendment referred to above, submitted in connection with registration under the Federal Insecticide,, Fungicide, and Rodenticide Act, as amended, for the addition of nine organisms to the product labeling, is acceptable with the following comments:

1. Amend the Directions for Use section of the label for the trigger foamer product, specifically, the "To Disinfect,..." directions must indicate if and how the product should be removed from the surface after the recommended "...10 minutes" exposure period. Likewise, for the non-foamer trigger product, the "To Disinfect/Deodorize,..." section of the Directions for Use should be amended to indicate if and how the product should be removed after the recommended exposure period.

2. Submit (5) five draft labels incorporating the revisions referred to above.

The Agency acknowledges your compliance with our request, as noted in previous EPA correspondence dated March 7, 1997, to submit revised labeling which moves the Ingredients Statement from the back panel label to the correct location on the front panel label.

A stamped copy of the labeling is enclosed for your records.


