TO DISINFECT, reapply, covering entire surface with foam. Allow foam to wet surface completely and let stand 10 minutes before wiping.

TO CONTROL MOLD AND MILDEW GROWTH on hard, nonporous surfaces, spray surface thoroughly. Allow to stand 10 minutes before wiping. Reapply as new growth appears.
