

FOLLOW DIRECTIONS and CAUTIONS CAREFULLY

DIRECTIONS

For best results start applications as soon as foliage appears, and repeat at 7 to 10 day intervals and after heavy rains. Apply more often (every 4 or 5 days) during rapid new growth or high humidity.

AS A DUST

Use a good duster. Cover BOTH SIDES of leaves thoroughly with light film of dust.

AS A SPRAY

Use a pressure sprayer. Mix contents with water at the rate of 10 level tablespoons (2/3 cupful) per gallon. Spray plants thoroughly covering BOTH SIDES of leaves.
