DIRECTIONS FOR USE

This product is an insecticide dust formulation for use by the commercial grower or commercial applicator. Apply when air is calm. To obtain most effective results apply with a ground duster or by airplane. Make thorough coverage of plants with a uniform deposit of dust. Use at the rate of 20-40 lbs. per acre.

RECOMMENDATIONS

BEANS: Aphids, Armyworms, Leafhoppers, Leaf Roller, Mexican Bean Beetle, Serpentine, Leafminer Spider Mites. Do not apply within 15 days of harvest.

BROCCOLI CABBAGE, BRUSSEL SPROUTS, CAULIFLOWER: Aphids, Armyworms, Diamond-back Larvae, Serpentine leafminer, Thrips. Do not apply 21 days of harvest.

CUCUMBER, SQUASH, MELONS: Aphids, Cucumber Beetles, Melonworms, Serpentine Leafminer, Stinkbugs. Do not apply to cucurbits before plants start to vine or within 15 days of harvest. Apply only when plants are dry.

POTATOES TOMATOES: Aphids, Colorado Potato Beetle, Flea Beetles, Grasshoppers, Leafhoppers, Red Spider Mites, Serpentine Leafminer, Whitefly. Do not apply on potatoes within 5 days of harvest; on tomatoes within 10 days of harvest.

COTTON: Aphids, Fleahopper, Garden Webworm, Red Spider mite, Thrips. Workers entering fields within 24 hours after application should wear protective clothing. Do not hand pick or harvest within 7 days. Do not apply within 15 days of harvest if cotton trash is to be fed to dairy animals or animals being finished for slaughter.

FORAGE CROPS — Alfalfa, Barley, Clover, Oats, Vetch, Wheat: Aphids, Armyworms, Blister Beetles, Grasshoppers. Do not apply within 15 days of harvest or forage use.

TOBACCO: Plant Bed Control — Aphids, Flea Beetle, Suckfly, Tobacco Hornworm, Budworm. Use 1½ lb. per 100 sq. ft. Do not apply within 5 days of handling transplants.

TOBACCO: Field Control — Aphids, Flea Beetle, Suckfly, Tobacco Hornworm, Budworm. Do not apply within 5 days of priming or 15 days of cutting. Avoid plant juices contacting skin when cutting crop.

WARNING: Rapidly ABSORBED THROUGH SKIN! MAY BE FATAL IF SWALLOWED, INHALED, OR ABSORBED THROUGH SKIN. DO NOT GET IN EYES OR ON SKIN OR CLOTHING. Wash hands, arms and face thoroughly with soap and water before eating or smoking. Wash all contaminated clothing with soap and hot water before re-use. Do not re-use Container. Destroy by burying in a safe place. Do not burn.
