GENERAL DIRECTIONS

Insect Control on Broccoli, Cabbage, and Lettuce:

For the control of aphids, cabbage looper, imported cabbageworm, apply 2% Phosdrin Insecticide Dust at the rate of 12½ to 25 lbs. (0.25 to 0.50 lb. actual) per acre.

Apply to give uniform coverage. Begin application when insects first appear and repeat application as often as necessary to maintain control. Do not apply within 1 day of harvesting for broccoli and cabbage and within 2 days of lettuce.

PRECAUTIONS IN USING

Do not apply or allow to drift to areas occupied by unprotected humans or beneficial animals. Unprotected humans and animals should be kept out of treated fields on the day of treatment. Destroy used containers by burning or burying. Keep out of smoke. Keep out of reach of children and domestic animals. Do not contaminate food or feed products.

This product is toxic to fish, birds, and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.
