

PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS.

CUCUMBERS: For the control of Downey Mildew and Aphids, Mellonworms and Pickleworms. Use 55 to 60 lbs. per acre depending on the size of plants. Pegin application by the time plants have 6 to 8 leaves. Continue application every 5 to 7 days. Do not use with 5 days of harvest.

#### STORAGE AND DISPOSAL:

Do not contaminate food or feed by storage, disposal, or cleaning of equipment.

#### STORAGE

Yeep this product in a tightly closed container when not in use. Store in cool, dry, well ventilated area away from heat or open flame. In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all material.

#### FEFTICIDE DISPOSAL
