For control of carp in farm ponds use at the rate of 2 - 3 lbs, per acre foot of water. Pump over water surface or bubble through underwater lines.

DETERMINATION OF ACRE FEET

- a) The term "acre-feet" designates a unit of volume having an area of one acre and a depth of one foot.
- b) To determine arce feet
 - 1) Make a series of transects across the water to be treated and sound with a weighted line or pole marked in inches and feet. Add the sounding measurements and divide by the number of soundings to determine average depth.
 - 2) Multiply average depth times total surface area to find acre feet to be treated.

- b) POWDERED MIXTURE Place powder in burlap sack and trail behind motor boat or premix with water and treat as liquid mixture. When treating deep water weight bag and tow at desired depth. Knead bag frequently.

RESTOCKING AFTER TREATMENT

- a) Wait 2 to 4 weeks after treatment.
- b) Place a sample of fish to be stocked in wire cages in the coolest part of the treated waters. If the fish are not killed within 24 hours, the water may be restocked.
