ANIMAL SPRAY: To protect animals against the attacks of horselies, stable flies, horn flies, mosquitoes and gnats, apply just enough to wet the ends of the haits but not enough to soak the hide. One to two ounces is sufficient to treat an adult cow. Apply once daily, preferable in the morning. Repeat at saily intervals or as necessary for continued protection.

SPACE SPRAY: To attain quick knockdown and kill of Tiles, whate, and mosquitoes in enclosed spaces, spray toward the ceiling and corners until the space is filled with a light mist. For best results, close all windows and doors prior to spraying and keen them closed for 10 to 15 minutes after spraying.
