

DIRECTIONS FOR USE
Dairy, Beef Cattle
LIVESTOCK FLY CONTROL

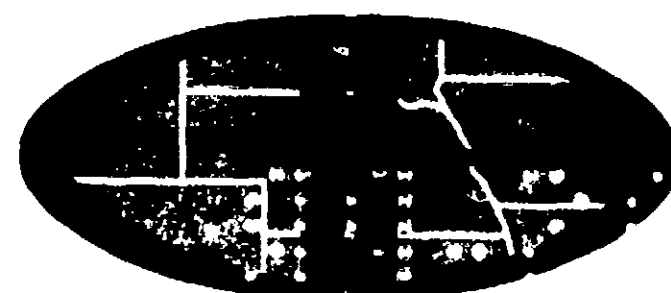
FOR MIST SPRAYING USING BASE OIL: For the control of Face Flies, Horn Flies, and Stable Flies, mix 1 quart Ciodrin - Vapona Concentrate with 18 quarts base oil (diesel or fuel oil). Apply as a fine mist at the rate of 2 oz. per animal. Cover all parts of animal thoroughly. Do not exceed 2 oz. per animal per day . . . Finished spray will contain 1% Ciodrin and .05% Vapona.

MIST SPRAY—Mix 1 gallon of Ciodrin - Vapona Concentrate with 3 gallons (1 quart per 1 1/4 gallons) of water. Apply as a fine mist at the rate of 2 oz. per animal. Cover all parts of the animal thoroughly. Do not exceed 2 oz. per animal per day.

"POUR-ON"—For the control of Horn Flies dilute 1 gallon Ciodrin - Vapona Concentrate with 14 gallons (1 cupful per 7 pints) of water, and apply by pouring 1 quart of the diluted emulsion along the backline of the animal. Repeat as necessary but not more often than once weekly.

BACKRUBBER—For the control of Horn Flies on Dairy and Beef cattle, dilute 1 gallon of Ciodrin - Vapona Concentrate with 18 gallons of fuel oil or other suitable carrier and charge backrubber device or sack or cloth as occasion requires. Retreat backrubber as needed. Do not spray animals with this oil solution.

LICE and TICKS—For the control of Lice and Ticks on Cattle, Sheep, Goats, Horses and Hogs dilute 1 gallon of Ciodrin - Vapona Concentrate with 50 gallons of water and spray animal thoroughly. Apply one to two quarts per animal for adult cows and one quart per animal for adult sheep, goats, and hogs. Dosages should be proportionally reduced for smaller animals. Make second application in 14 days if needed. Repeat as necessary but not more often than once weekly.

DIRECTIONS FOR USE

BARN FLY CONTROL—As an aid in the reduction of House Flies, Face Flies and Stable Flies in Dairy barns, animal shelters, hog barns and poultry houses where Flies are a problem, mix 1 gallon of Ciodrin - Vapona Concentrate with 25 gallons (1 pint per 3 gallons) of water. Spray mixture on surfaces where flies alight and feed. Spray surface to run-off. To improve control add 1 pound of sugar to 6 gallons of spray solution.

WARNING: Hazardous if swallowed, inhaled or absorbed through skin! Do not breathe spray mist. Do not get in eyes, on skin, or clothing. Wash with soap and water after using and before eating and smoking. Avoid contamination of feed, water and foodstuffs. During commercial or prolonged exposure in spray mixing and loading operations, wear clean synthetic rubber gloves and a mask or respirator of a type found suitable by the U. S. Department of Agriculture for protection against Ciodrin Insecticide.

To protect fish and wildlife, do not contaminate streams, lakes or ponds with this material.

Do not use this material on Brahman or Brahman cross cattle.

Do not reuse container. Destroy when empty.

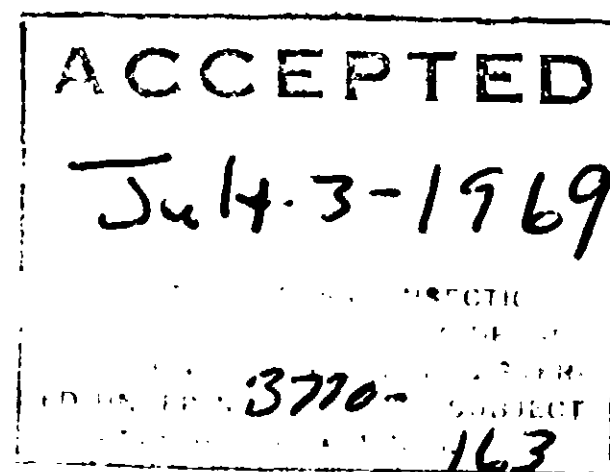
ANTIDOTE: External—In case of spillage on person or clothing, immediately remove clothing and flush skin or eyes with plenty of water; for eyes, get medical attention.

Internal—Call a physician immediately, give emetic of mustard. Large doses of Atropine are antidotal.
