

DIRECTIONS

To protect **beef cattle** against **horn flies**, use this solution undiluted. Apply the material to saturate the backrubber mechanism. The amount of material needed for the applicator will depend on the size of the reservoir and the type of covering. One to two gallons will be needed for application with the reservoir while those without it should be charged by saturating the exposed burlap, felt or cloth portions of the applicator. Subsequent recharging to maintain effective results should be done when needed.

May be used to aid in the reduction of **lice** on **hogs** and **beef cattle**. In most

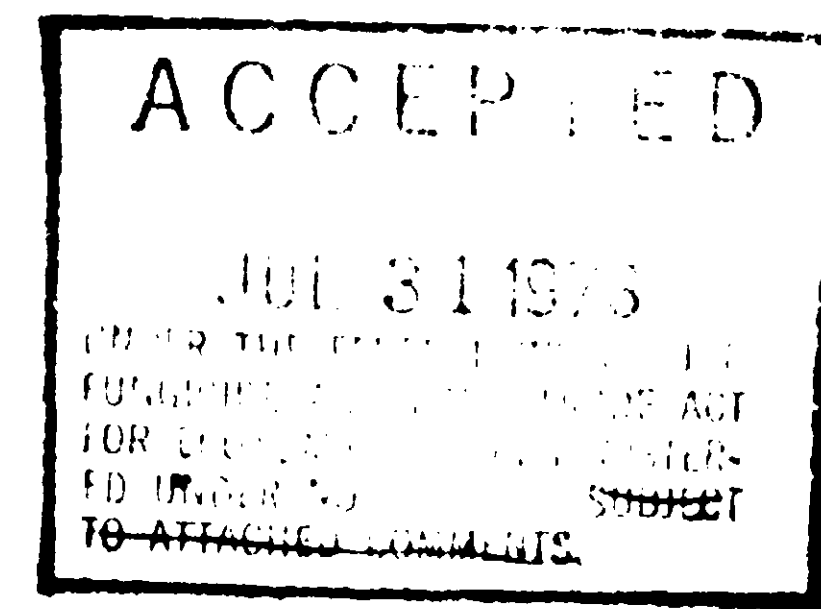

DIRECTIONS

For cases the rubbing of the animals against the device or applicator will distribute the oil solution over the body sufficiently to control lice.

Locate backrubber to give beef cattle and hogs free access. Best locations are usually watering places, salt licks or feed racks and loafing areas.
