DIRECTIONS FOR USE

Apply with a regular sprayer giving a coarse spray for the control of insects in supermarkets, restaurants, homes, institutions, food handling establishments, food processing plants, warehouses, furniture storages and libraries. Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Will not mix with water. Caution — Do not spray near open flame, pilot lights, heating elements, or other sources of heat.

Roaches, Ants, Silverfish, Waterbugs, Spiders, Crickets:

Spray directly on insects where possible. Also spray to wet insect trails and surfaces wherever insects may breed or congregate — under sinks, drainboards, stoves, refrigerators, in cabinets, around baseboards, door sills and frames, window frames, garbage cans, garages, and out-buildings. Re-treat as necessary.

Fleas in Buildings and Pet Quarters:

Spray thoroughly floors, walls, rugs, carpets, cracks, crevices, sleeping quarters of pets. Re-treat as necessary. Do not treat pets.

Carpenter Beetles:

Apply to floor areas and baseboards. Spray directly into cracks, crevices, and under carpets where insects may be found. Treat both the underside and topside of infested carpets. Spray inside of trunks, closets and infested areas of shelving. Re-treat as necessary.

DIRECTIONS FOR USE

Bedbugs:

Spray mattress and bedding lightly including seams and folds. Spray bed frames, springs, along baseboards, carpet edges, cracks. Apply liberally to inside walls and floors of laundry trucks.

Flies, Mosquitoes, Small Flying Moths and Wasps:

Spray surfaces until wet where these insects alight or congregate — walls of porches, garages, house foundations.

Fleas and Ants Outdoors:

Spray to wet localized infestations of these insects. For ants, thoroughly wet hills and runways. Re-treat as necessary.

ENVIRONMENTAL CAUTION — This product is toxic to fish. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

CONTAINER CAUTION — Do not reuse container. Destroy it by perforating or crushing. Bury or discard in a safe place away from water supplies.
