ONE OUNCE MEASURING SCOOP ENCLOSED

SEED CORN TREATMENT—A Planter Box Treatment for temporarily protecting germinating seed and young seedlings from seed corn beetles, seed corn maggots, wireworms and white grubs.

PLANTER BOX APPLICATION: Use by mixing with the seed in the planter box. Sift directly on the seed in the planter box, or may be mixed in a rotating container such as a cement mixer. Best protection will be obtained where every seed is coated with the chemical. **DO NOT USE** treated seed for food, feed or oil purposes.

RATE OF APPLICATION: Seed Corn: 6 oz. per bushel of seed.

KEEP PLANTER PLATES CLEAN—Grease or oil on plates can cause clogging.

WARNING: MAY BE FATAL IF SWALLOWED. MAY BE ABSORBED THROUGH SKIN. Do not breathe dust. (Where the material is applied to seeds dry as a powder, work in a well ventilated room.) Avoid contact with skin, eyes and clothing. In case of skin contact, wash thoroughly with soap and water. For eyes, flush with plenty of water. Wash thoroughly after using. Avoid contamination of feed and foodstuffs. Keep out of reach of domestic animals. Do not use on household pets or humans. Do not use treated seed for feed, food or oil purposes.

ENVIRONMENTAL CAUTIONS: This product is toxic to fish, birds, and other wildlife. Treated seeds exposed on soil surface may be hazardous to birds and other wildlife. Do not allow treated seeds to be exposed on bare ground. Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

CONTAINER DISPOSAL: Destroy container by punching holes in it and burying with wastes, or by burning. Stay out of smoke and fumes.
