Place baits in areas inaccessible to children and pets.

Caged Poultry and Turkeys on Wire: (Flies): Sprinkle Scatter Bait at the rate of ¼ lb. per 500 sq. ft. on droppings beneath cages or perches. Repeat at weekly intervals.

Poultry Houses: (Flies): Sprinkle Scatter Bait at the rate of 1/4 lb. per 500 sq. ft. where flies congregate but keep out of reach c' birds. Apply to manure, on window sills, outside of penned enclosures and on floor of feed storage room. Repeat as necessary.

Dog Kennels: (Flies): Sprinkle Scatter Balt at the rate of 1/4 lb. per 500 sq. ft. outside dog runways, on window sills, ledges and other surfaces out of reach of animals. For caged units apply to dropping area. Repeat as necessary

Garbage Cans: (Flies): Apply Scatter Balt around and inside garbage can. Repeat as necessary.

Dairy Barns, Milk Sheds, Stables, Livestock Barns, Loafing Sheds, Pig Pens and Outdoor Areas: (Flies): Sprinkle Scatter Bait at the rate of ¼ lb. per 500 sq. feet on floor or ground areas where flies congregate. Ideal baiting sites are around doorways, feed storage rooms, alleyways and window sills. On freshly limed floors place treatment on waste cloth or on paper. Repeat procedure as necessary for practical fly control.

For Reducing Populations of Resistant and Non-Resistant Houseflies in and Around Outdoor Living Areas, Picnic Grounds, Backyard Area, Patios, Loading Docks, Outdoor Latrines, Parking Areas, Refuse Areas Around Service Stations, Open-Air Drive-Ins, Ice Cream Stands, Garbage Collection and Disposal Areas: Use Scatter Balt at ½ lb. per 500 sq. feet of area. Apply on ground or areas where flies congregate. For open-air drive-ins, ice cream stands and restaurants, apply on apron between serving counter and parking area, paying particular attention to trash barrels and garbage cans where flies congregate.

In food processing plants, restaurants, or other places where food is commercially prepared or served, use only when the facility is not in operation and food is not exposed. Use only in bait boxes where bait in each box can be accounted for. Remove and account for all bait boxes prior to resuming food processing.
