DIRECTIONS

TOMATOES: Blister beetle, Colorado potato beetle, flea beetle, green peach aphid, tomato horn worm, white fly, cabbage looper, tomato fruit worm, tomato russet mite, yellow-striped armyworm, tomato psyllid, early and late blight, anthracnose, stemphylium and Septoria leaf spots and cladosporium gray mold.

Apply a thin, uniform covering of dust to all plant surfaces. Begin dusting when disease or insects are first noted and repeat application at 7 to 10 day intervals or oftener under late blight conditions.

Do not apply to tomatoes within 1 day of harvest.

CAUTION

Harmful if swallowed, inhaled, or absorbed through skin. Do not breathe dust. May be absorbed through skin. Avoid contact with skin, eyes, or clothing. In case of contact with skin or eyes, flush with plenty of water; for eyes, get medical attention. Wash with soap and water after handling and before eating or smoking; wear clean clothing. Avoid contamination of feed and foodstuffs. Do not apply or allow to drift to areas occupied by unprotected humans or beneficial animals.

Note to Physicians: **Endosulfan** is a central nervous system stimulant and may caus: convulsions. There is no specific antidote. Barbituric acid derivatives may be used in treatment.
