DIRECTIONS FOR USE

PRESSURIZED HOUSEHOLD INSECT SPRAY KILLS EVEN RESISTANT ROACHES — For use indoors or outdoors. Hold can upright and spray infested surfaces only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS — Spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and trails and other localized areas infested with insects. Spray around window frames and door frames where ants enter. Repeat as necessary.

CARPET BEETLES — Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets, where insects may be found. Treat crevices, cracks and infested areas of shelving in closets. Repeat as necessary.

BROWN DOG TICKS — Spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of pets and localized areas of floors and floor coverings. Repeat as necessary. Fresh bedding should be placed in animal quarters after treatment. Do not treat animals.

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS — Outdoors — For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces or screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

CHIGGERS, ANTS, BROWN DOG TICKS — Outdoors — For treatment of localized infestation of insects in outdoor areas, spray infested areas. For ants, wet hills and runways. Repeat as necessary.
