

PYRETHRIN GARDEN INSECTICIDE DUST

DIRECTIONS

Pyrethrin Garden Insecticide Dust is intended for use as a contact insecticide during the growing season. Treat only when insects are present and repeat as required to maintain control. Apply dust uniformly to upper and lower leaf surfaces. This Pyrethrin Dust protects vegetables and ornamentals.

On Vegetables: Asparagus (Asparagus Beetle), Beans (Leafhoppers, White Fly, Mexican Bean Beetles), Broccoli, Cabbage, Brussels Sprouts, Cauliflower (Cabbage Looper, Cross-striped Cabbageworm, Diamondback Moth Larvae, Flea Beetles, Harlequin Bug, Imported Cabbageworm), Celery (Cabbage Looper, Leaf Tier), Cranberries (Fireworms, Leafhoppers), Eggplants (Colorado Potato Beetle, Flea Beetles), Lettuce (Cabbage Looper, Diamondback Moth Larvae, Imported Cabbageworm), Peppers, Potatoes (Colorado Potato Beetle, Flea Beetles, Leafhoppers), Radish (Flea Beetles), Spinach (Cabbage Looper, Webworm), Tomatoes (Colorado Potato Beetle, Flea Beetles).

On Ornamentals: African Violets, Asters, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Dahlias, Dogwood, Geraniums, Gladioli, Marigolds, Roses (Flea Beetles, Leafhoppers).
