We have reviewed the label and Confidential Statement of Formula (CSF) submitted with the above letter and have the following comments.

A. Revised Labeling

This submission seeks to modify the label to exempt the product from the requirements of the 1995 Ziram Data Call-In, which required the submission of residue chemistry data to satisfy Phase 4 of the reregistration of Ziram (Case No. 2180, Active Ingredient Code 034805).

This submission also attempts to bring the product up to current labeling requirements. The Agency last accepted a label for this product on March 5, 1973, almost 24 years ago.

The revised labeling, as modified below, does fulfill the purpose of exempting the product from the 1995 Ziram DCI and does bring it up to current labeling standards. Unless the 1995 Ziram DCI required different due dates for existing stocks of formerly approved, non-complying labeling, you will have 18 months, from the date of receipt of this letter, to use up existing labeling. For less volume use 4 teaspoonfuls per pint of water. For easy mixing, paste the material with a small amount of water, then dilute.
